How: All sections of this petition must be filled in accurately and completely by the petitioner(s) and filed with the court. In addition, this petition must be verified and signed before a clerk of this court or a notary public.

Copies: The original petition must be submitted to the court. The following documents listed below should accompany the petition:

- 1. Child(ren)'s certified copy of Birth Certificate
- 2. Child(ren)'s certificate of Indian Blood
- 3. Petitioner(s) certificate of Indian Blood, if any

Fee: \$35.00 filing fee paid to the Northern Cheyenne Court. Money Order Only

These requirements are pursuant to the Northern Cheyenne Law and Order Code, Title III, Chapter 3, §§§ 3-3-2(B), petition requirements 3-3-4, set out in 3-2-12 of this title.
