How: This petition must be completed by the petitioner(s) and filed with the court. In addition, this petition must be verified and signed before a clerk of this court or a notary public.

Copies: The original petition must be submitted to the court. A colored copy of the documents listed below should accompany the petition:

- 1. Child(ren)'s certified copy of Birth Certificate
- 2. Child(ren)'s certificate of Indian Blood
- 3. Proof of a court order terminating the parent-child relationship with respect to each living parent of the child. (Required to proceed)
- 4. Copies of orders, guardianships, etc.
- 5. Petitioner(s) proof of marital status, if appropriate
- 6. Petitioner(s) certificate of Indian Blood, if any

Fee: \$45.00 filing fee paid to the Northern Cheyenne Court. Money Order Only

These requirements are pursuant to the Northern Cheyenne Law and Order Code, Title III, Chapter 5, §§ 3-5-1, 3-5-2.
