VENDOR RULES AND REQUIREMENTS (No Exceptions):

1. Must Meet All Tribal EPA Sanitation Standards At All Times (Inspections Daily)
2. Must Keep Entire Vendor Space & Surrounding Area Clean At All Times
3. Food Vendors Must Have Two (2) Trashcans Available At All Times
4. Food Vendors Must Have a Fire Extinguisher & a First Aid Kit Available
5. Food Vendors Must Dispose of All Waste Materials Safely (Including Grease)
6. Novelty/Apparel Vendors Are Prohibited from Selling the Following:

Lasers, Silly/Party String, Potato Guns, Stink Bombs, Dangerous Weapons, Pornography, Fire Crackers or any other items determined by the Committee

VENDOR AGREEMENT

VENDOR MUST MEET ALL REQUIREMENTS ESTABLISHED BY THE NORTHERN CHEYENNE TRIBE AND CHIEFS POWWOW COMMITTEE IN SETTING UP THEIR BUSINESS FOR THE "NORTHERN CHEYENNE CHIEFS POW-WOW CELEBRATION"; AND IF VENDOR RULES AND REQUIREMENTS ARE NOT ADHERED TO, VENDOR FEES WILL BE DOUBLE FOR THAT DAY AND/OR VENDOR WILL HAVE TO LEAVE. THE TRIBE AND COMMITTEE WILL NOT BE HELD RESPONSIBLE FOR ANY ACCIDENTS, INJURIES, OR THEFTS THAT THE VENDOR MAY EXPERIENCE; AND THE NORTHERN CHEYENNE TRIBE MAINTAINS JURISDICTION OVER ANY GRIEVANCES BROUGHT FORWARD BY THE VENDOR. THE VENDOR MUST WORK CLOSELY WITH THE POWWOW COMMITTEE AND THE COMMITTEE'S VENDOR COORDINATOR ON ADHERING TO ALL THE POWWOW VENDOR RULES AND REQUIREMENTS, VENDOR SPACE & LOCATION, VENDOR PAYMENTS AND OTHER CONCERNS.

NORTHERN CHEYENNE TRIBAL MEMBERS MUST PROVIDE PROOF OF ENROLLMENT. NON-TRIBAL MEMBER INDIANS MUST ALSO SHOW PROOF OF ENROLLMENT IN ANOTHER TRIBE.
