Judge Brady-In the last four years, not one tribal Council has been down to the Court. I would appreciate if you guys would come down there. I would like you see what we have to do to make sure confidentiality stays in the court system.

Sheldon King-Two years ago, you did invite us down. We did a walk through.

Judge Brady-For a year now, I've been running the court by myself. I ran that court by myself for a whole year. We really need the Council, and Vice President to come down. I want to be able to show you where it leaks, it's a tin building that has not been changed since 84. It's tough to walk into a court, where we don't have support. The only time we're called up here is only when there's negativity. We want positive stuff to come out of that court.

Vice President Fisher-I appreciate your invitation to come down there. This idea of separation of powers, to look at it like it's autonomous, there was a lack of communication, we haven't gone down there as we should. I think those things, to say we've never been down there. A lot has to do with respect for the court. On the structure and other areas, we should maintain some kind of distance. Your invitation is welcome.

Judge Brady-We need to able to have the Council know the issues of the court. I appreciated the support and appreciate your appointment.

President Killsback-I can commit, our resources and programs, to buildings and expansion of services. We can look at creating a plan, keep that communication open. I hope we take time to get down there.

ELDERLY UPDATE-NOT PRESENT

President Killsback-We want you to know that we're not considering putting elders on the Elder Commission. Maybe some young people that can push elder issues. We want to get away from that narrow view of what the commission can do. I'm giving you a heads up on the special meeting for the boards.

DISTRICT UPDATE

Lenny Elkshoulder-Congratulate newly elected Council. I'm impressed with the Council that do come in early. The banker's hours need to stop. As for the district updates. I wasn't able to gather the information that I needed. Councilman King, is Eloise Snow working at Busby School?

Sheldon King-She volunteers, she goes in to help.

Lenny Elkshoulder-If you want to a job you should apply like everyone else.

Sheldon King-She doesn't work there.

President Killsback-Keep it on the update of the district. Keep it organized.

Lenny Elkshoulder-as far as district updates, that was one of the issues that my community brought up. It's nothing personal, if they bring a concern to me, I have to bring it here. I'm the one that has to take all the fire.

President Killsback-We have a stalemate with Lame Deer District. I would look to the leadership of the Lame Deer District to help your community to resolve the issue. Getting that clear so they can spend their Permanent Fund allocation and to bring the conflict to be resolved. The stalemate in a nutshell is, Georgia. Another group had a meeting and voted to have an election to vote in a new group.

Melissa Lonebear-Kris was recognized by the Lame Deer district, as Chair. They took action recognizing her and they have minutes. The meeting that was held was opened by Kris and the election was held.

President Killsback-Everyone has different plans of operation, we don't want to interfere because we can't. They have to deal with their own, it is tying up that resource. My office is not going to choose. I do have a concern with a Muddy district person being in the district.

Joe Fox, Jr.-I think that was a good, it would alleviate some of the issues that we're facing now. Some of the district chairs, it's within our constitution are you going to be able to set up some meetings with them.

President Killsback-If they determine their leadership, I can consult with district councils. We have three seats or four, I'm really relying on them. There's definitely an impasse, the Constitution says that I do all the appointments.

Joe Fox, Jr.-A lot of the items with the district chairs if they had a personnel issues, those can be addressed at your level.

President Killsback-I want to control the meeting, keeping it concise, make sure we're giving people right information. We want to limit that style of meetings. It's very disruptive.

BIA SUPERINTENDENT UPDATE-NOT PRESENT

IHS UPDATE-DEBBY BENDS

Debby Bends-I want to congratulate all of the new Council members. I'm happy to meet with you today. Staffing-We've had some vacancies, our cumbersome HR process. We did interview

a physician from Billings last week. Dr. Potter, he is a general surgeon, he backed away from surgery, wanted to have more day to day interaction with his patients. He applied to IHS and is very excited about the concept of Tribal Health. On December 19th at noon, there will be a luncheon forum. Doctors are hard to come by. We are going to have another pediatrician vacancy, we will still have one. Also, recruiting for Chief Medical Officer. In terms of dental, we were down several vacancies. It was easier to recruit for some reason. We have made a selection for a chief dental officer, we will have a hygienist. I have to commend Tori Darkenwalh, she has gotten more done in the last two months, than the last year. She is the clinical applications coordinator. I'm amazed at how much she's gotten accomplished. We are changing has dental was, there was so many complaints. PRC services-we continue and closed out at a level 4. Most referrals got approved, there's been a great increase in Medicaid eligibility. A lot of people are on Medicaid not because of Medicaid expansion. Most of those referrals are nephrology. The staff are super busy.

Vice President Fisher-In layman's terms what is that?

Debby Bends-It has to do with kidney functions. I think tel medicine is really going to be a big thing here. The biggest thing is for patients so they don't have to go to Billings.

Vice President Fisher-Are you looking at the possibility of having the service here?

Debby Bends-Are you asking about dialysis? Jace worked on that, when he was the Tribal Health Director. A portion of them will end up on dialysis.

Vice President Fisher-It's important to have the service. The questions and your recommendations are very important. There should be recommendation from IHS, I don't know if you do consult with the Tribe rather than taking a neutral perspective.

Debby Bends-I have attended meetings and discussed issues. It takes three to four hours of your day when you're on dialysis.

Vice President Fisher-I think it's important to have frank discussion. It's important for the Council to know we're all in it together. All those folks need to have a partnership in addressing this. The folks on dialysis and have to go to Billings, at least take it seriously.

Sheldon King-Is there a possibility of finding funding? Shakopee did mention that they were willing to buy machines.

President Killsback-This is perfect timing for the orientation you are getting this weekend. We are proposing to take 1/3 of the function of Crow/Northern Cheyenne hospital. We're online with a lot of people had already mentions that they had said that we need to look at the prevention side of it too. We're stuck in a specialized type of care that we provide. Not only in the region, we can expand, we should expand, physical, lifestyle, and healthy food choices.

Vice President Fisher-You've been there a long time and we'd like to have your input on a very serious disease we have on the reservation.

Debby Bends-I appreciate your comments as well, I'd certainly like to be on the group to deal with the dialysis discussion. We would welcome being a partner in that.

Waylon Rogers-Me, my niece and sister, have a rare high blood pressure that's hard on our kidneys. We're at a low risk for diabetes, it will probably do the same thing to me as my sister. My sister died from pneumonia, it's something I have to deal with when I get older.

Ernest Littlemouth-I have a question on transportation. Do you have enough drivers down there?

Debby Bends-All of our positions are filled.

Ernest Littlemouth-One time all the ambulances were out, they had no drivers.

Debby Bends-My door is open, you can come to my office to have further discussion on this.

Willie Rowland-You take dialysis patients to billings, it's like herding cattle through there. My sister goes to Sheridan, it's a top notch deal there.

Debby Bends-They're very small, they don't have the capacity. Your sister is very fortunate to get in there. They get very upset when they're late. Ultimately people get shorted on the van. The concept of dialysis is so important

Sheldon King-My dad goes to the Billings Clinic one, it is better than the one at Rocky.

President Killsback-We need to put some language in there, discrimination is still alive. I want to encourage Council to tell constituents to include follow up and feedback. There's some strict guidelines as far as HIPPA. These are good topics on the orientation we're having this week.

Debby Bends-If the patient doesn't voice their issues, the more we know, the more we can address. The only other thing, there' will be a 638 contracting training next week 12/13 & 14. It's up in Billings. Also, we put up a big Christmas Tree, we're putting the angels on the tree, that primarily come from the foster care program. It would be great for the tribal leadership to participate in.

Merlin Sioux-There's three things I need to start a foundation.

President Killsback-The Board of Health has that information. We wanted to do exactly that. We have to remember, when transportation retroceded, it took our ability to do the lodging, meals, and gas. If the Tribe takes it, we're more flexible. It's something we have to see if it's best for us to take.

Debby Bends-I'm totally open to meet periodically. When is the orientation to the Board of Health?

President Killsback-I signed the agreement for the PRC, we're moving forward with Board of Health to sign people up for tribal members. That's something we look forward to in the New Year.

Debby Bends-I'd like to attend that if I may.

President Killsback-We'll get back to you on that.

Debby Bends-The budget formulation was held, we did go with the same medical priorities, our Tribe went with same. Mental, Substance Abuse, Dental, and PRC. They went with the top 9, I don't have those with me. They look at how the dollars are applied. All & all it went very well, the tribes got to provide. They usually elect a tribal representative to take the lead.

MINUTES

President Killsback-These minutes are not approving the action, they're approving the record of the action. Too often we think that. It doesn't change the action that was already voted on. I don't know how the Council wants to proceed.

Ernest Littlemouth-I've been here since May and haven't gone through them yet.

William Rowland-Now that we're caught up, I'd like to have the minutes for the next meeting as they're supposed to be.

Vice President Fisher-I just want to emphasize what Willie was saying. I know that you've been an asset to the Tribe, and do a lot of wonderful things. They are critically important as far as staying focused. I think we've mentioned this with the old Council last year. I look forward to working with you Melissa. I think we can agree, we need to have these minutes every Council Meeting. I think we can make it work, we're willing to work with everybody. I think it's important for everybody here, we're all in agreement, and we're all in agreement and we need the minutes before the meeting.

President Killsback-We're starting this administration with a clean slate.

NCUC BOARD APPOINTMENTS-SHERI BIGBACK BEMENT

President Killsback-I am demanding that you allow my office to make appointments. We have gone through potential appointments for those boards. I would ask that this body table this appointment. I extended your appointments, because you are check signers. The Constitution says the President has the power to appoint. In future reference, I'd like a stronger communication. I asked the Directors that I be in that line of communication. We do have a directors meeting.

Sheri Bement-I've been in this position for 3 months. This was put in place so we couldn't have rate increases with our utilities bills. Doris spearheaded this, we would like this moratorium lifted so we can raise our rates.

Doris Limberhand-I've been working with NCUC since 2006 on different projects. In 2009 we've not had a rate increase, we have a proposal to raise the rates by \$2.00. In order to act on a proposal. We have met with the council on two occasions, once in September and once in November. We understand and respect and understand the elderly, we will continue that reduced rate. We know the economic situation here. We have a documented valid request for our sewer services. What we propose is that we have a \$2.00 rate increase for the next four years, for all five reservation committees. We recently revised our billing and collection policy.

Ernest Littlemouth-Who put it in, it won't affect the commercial customers.

Doris Limberhand-The commercial rates are from per cap basis.

President Killsback-Ideally in the future, I'd like them to be set up in separate meetings. We already know what we're discussing. I'm looking at it now. We want to proceed, it's up to the Council?

Merlin Sioux-I recommend a working session first, we do have new Council members.

President Killsback-We know on the lagoon issue, that we need to have an increase here. They want commercial to feel the brunt, not the low income people. You were handed a system that was already failing. I think we can connect with program directors that can move that forward. When we were discussing that, the rate issue did come up. May

Vice President Fisher-I hope there is a timeline, and I know you want to move forward on this.

President Killsback-The working session we had in regards to 5 (97), we asked for guidance and clarification. The Treasurer & Secretary overseeing personnel. If a grievance is filed, it would go to the Council. The Council is separate from all personnel issues. The accountability piece, there has to be a way for all of us to be accountable. Things like timesheets trip reports and travel. You will be a designated signer for timesheets, and leave for the treasurer and secretary. Look at the authority over the tribal treasurer and secretary. The 2nd Whereas, 3rd Whereas, the provisions of the personnel manual to the President or Council member. They're retaining all the other supervisory authority to discipline or replace. The last sentence will retain all the authority. That was key in our discussion, it included that language. It is signatory authority, in order to implement the personnel manual functions that apply. It gives you specific items in 5 (97). The bottom of the page, therefore be it ordained. It rescinds, we should be afforded that right for grievances for personnel. Activity, tracking and reporting for all officials. The Tribal Council revises the System of Operations for reporting for officials. It gives a policy. There is some implementation that needs to occur with this. Brian and I looked at this. We're talking who signs whose timesheets, who signs whose leave. I know we're all salaried, not necessarily

to provide evidence and reporting, those activities need to have lists to identify some administrative record for our work. How do we quantify these salaried positions?

Melissa Lonebear-It's backwards, you're explaining it backwards. Employees still have an appeals process.

Ernest Littlemouth-I think all of us need to be here, all the time. We need to be here for our people. We need to start doing our timesheets our leave slips. Cowboy made me do mine. I need people to see I'm doing the right thing on the Council.

President Killsback-We were all in that meeting, I want to know if we're able to move forward. I need to utilize the staff so it doesn't lead to the Tribal Council.

Joe Fox, Jr.-On your supervisory part of it, the secretary & treasurer work for the Tribal Council.

President Killsback-There's instances for the employee to have due process, we can't have Council oversee personnel matters. It creates continuity.

Sheldon King-I wasn't' here to go over it.

Vice President Fisher-I think we have to look at the employee, they have a right to an appeal. That's the bottom line, we want to look at consistency. They should have an appeals process.

Sheldon King-Speaking with Brian today, no matter what, we're still following the policy. We make decisions as a council, we follow policy.

President Killsback-This is changing the policy, to allow for Ernest and Dana to sit on the Ad Hoc Board.

Dana Eaglefeathers-It's a temporary change.

President Killsback-Just for appointment purposes. Another Ordinance will come into play to become the new law. This law is establishing the Ad Hoc School Board. This amends the, no felons on the board. These appointments, are still my appointments. I think it's important to have two Busby representatives.

Joe Fox, Jr.-Part of our rules, if the elected board takes over, we have to come in and change it back.

President Killsback-Generally, we don't know all the laws that are out there. Sometimes someone will pull out a resolution saying you can't do this.

Joe Fox, Jr.-A suggestion was why can't we appoint two others?

Sheldon King-I make a motion to find two others to appoint to their board. We follow the rules of the policy at hand there.

President Killsback-Is the Council okay with my recommendation?

Joe Fox, Jr.-I recommend Willie Rowland to sit on there temporarily.

Dana Eaglefeathers-I recommend Merlin Sioux.

Both declined. Joe Fox, Jr. and Benji Headswift volunteered to sit on the Ad Hoc board temporarily.
