**ANNOUNCEMENTS**

Sheldon King-All we hear is that \$500,000 was turned back last year. Is that what you heard when you went down there?

Vice President Fisher-It could have been better spent. I think we need to sit down and take a good look at our Headstart program.

Sheldon King-We could have possibly got a new unit in Busby. The Director is not aggressive enough to take care of our kids. Our teachers, they need a better wage. We sat here for almost four years and that was my goal that we get a better Headstart.

Vice President Fisher-What I can do, is sit down and have a follow up.

President Killsback-With Headstart, there was legislation here. That law we were going to pass, took the policy committee out on the disciplinary of the director. That's something to follow up

on and he was supposed to present that again next week. If there is accountability that needs to occur, we want it streamlined.

Sheldon King-We went to D.C. We want at least 2% of that transportation money to come back. We're trying to unite as one. I also had the opportunity to get with NIGA out there. In front of the meet & greet, he said there's big things being done at Northern Cheyenne.

Debbie Charette-We had James Casen and he basically said that he wasn't going to help with TBEC.

Sheldon King-We did buy a propane tank. We are filling a need on the reservation.

President Killsback-On the propane deal, I wanted to see some of the other documentation on it. The business plan, and quotes, let us know.

President Killsback-I spoke to the US Commission on civil rights. I gave a presentation on border town racism.

Dana Eaglefeathers-Make a motion to add.

President Killsback-I'm not sure if I'm going to recognize that.

Vice President Fisher-I'm not sure who the agenda committee is, in the past, we set and agenda. You're trying to bring order and trying to be consistent. That's going to be the biggest question, if you have a process in place, then the agenda committee should be the authority on whatever stipulations you place on it. In the past, we've always done that.

President Killsback-All I'm asking for is consistency. Policy is there to guide us. Ultimately, it's up to the Council.

**GAMING HIRING PROCESS-SHELDON KING**

Sheldon King-I'm not out to pick on anyone. We didn't advertise the position. On one side of the spectrum it said Gaming Commission could appoint, and the other said it should be advertised. I always advocate equality. As long as it's advertised, I don't care who the commission picks. There's people out there that might want to come home. I wanted to open the door for everybody.

Dana Eaglefeathers-This is one of the entities that is actually doing well right now. We go back to separate entity, just like housing. They have their own governing documents. The new GM is working closely with our attorneys to revamp the policies. I don't see it as nothing but dictating. We want to dictate how they operate. In less than 90 days, he's generated a lot of money from that casino. We're looking at 21 million dollars in fines for utilities. Curtis is the GM to come up with a financial management plan. I really don't think stepping in and dictating is good leadership.

Sheldon King-With our gaming commission, even with Mr. Small, even with Terry we advertised. We walk in to a position, with the audit, we were in the red \$43,000. All I'm asking for is equality for advertising, just like every other position that's out there. It's unfair to our people that we don't advertise every position.

Benji Headswift-I feel that if they did advertise, he would have been permanent already. I did talk with Curtis at the last Council meeting. If that were me, I would want to have that security of having a job.

President Killsback-I read the Ordinance, and policy. Appoint also means hire, we're confusing it as appointment. It's giving the commission, hiring and firing authority. Our policy is also clear on how we select, review, and hire.

Dana Eaglefeathers-To clarify what Benji said, he was appointed permanently for one year. The Vice President agreed to it.

Vice President Fisher-You want to clarify the rules for hiring the Gaming Manager. I hear discussion that they're doing that now.

Sheldon King-It just says that they're going to advertise. We're looking at needing more clarification.

President Killsback-My understanding, is that if we pass it, the Commission will advertise the position. The pressure is coming from the community. I understand it now. I've asked the Gaming Manager to give me the minutes and I still haven't received those.

Leonard Elkshoulder, Sr.-About a month ago one of the commission members approached me. He asked about the Ordinance. He said every time they hire someone that seems to be doing something right, the council steps in and wants to get rid of them. He approached me and asked me if I read the gaming commission, in the ordinance, it spells out that the commission will hire a gaming manager. A board member approached me, and he said, the Council already has someone in mind for that. When these kinds of things come up, you should all call those commission members in. Why does this Council arbitrarily do these things? I've never been on the Council in my life. That's something to think about.

Sheldon King-At the gaming meeting, a tribal member abruptly lost his job. There was no due process for him. In that meeting, in the minutes, he came in there and it was in the minutes that they were going to hire for that position. I didn't know they picked the gaming manager. We're not there to pick on anybody. If one person was fired from his job, at that time we should have advertised.

Dana Eaglefeathers-I think we should send this back to the gaming commission, let them make those changes.

Dana Eaglefeathers-Again, we're going back to the Gaming ordinance. The ordinance says that the President, and Vice President are ex-officio's of the gaming ordinance. I don't think the gaming commission needs a liaison.

President Killsback-I talked to Sheldon about having him as a liaison. This resolution will still go to NIGC. I know all of us can go to the meetings, but there's also regulations. If we do this officially, need to add that I am appointing to you, or delegate that ex-officio status.

Dana Eaglefeathers-I would recommend Waylon.

President Killsback-I told him not to nominate himself, we shouldn't nominate someone that's not here.


