The Northern Cheyenne Tribe is now accepting sealed bids for the Northern Cheyenne Tribal Schools (NCTS) consisting of Dish-wash Room Renovation Services for Building #204 Main School.

The contractor shall furnish all materials, labor and equipment needed for the Dish-wash Room Renovation Services for Building #204 Main School. This bid should include (but is not limited to) the following:

Scope of Work:

1. To propose material and labor.
2. Remove and replace with new (1) Commercial type dishwasher with booster.
3. Disposal of old dishwasher must be done in accordance with State and Federal Law.
4. Installation includes electrical and plumbing.
5. Remove (2) 5Hp Salvajor disposals and dispose of properly.
6. Some Stainless still work to be performed.
7. All bidders must have General Liability Insurance and be TERO certified.
8. Prospective bidders must contact the NCTS Facilities Manager, Duane Swank Sr. at (406) 720-0126 to schedule a date and time for a site visit of work needing to be done.

Emailed or faxed proposals will not be allowed and late bids will not be considered. All required documents must be in the sealed bid prior to the bid opening.** No bids may be withdrawn after the scheduled time for the public opening of bids. REQUIRED DOCUMENTS INCLUDE THE FOLLOWING:

INDIAN PREFERENCE. The owner will factor Indian preference into the bid analysis process however it will in no case be the sole deciding factor in awarding the work. Evidence of eligibility for Indian preference must be submitted with the proposal. Responsible bids will be accepted from Non-Indian owned contractors. In evaluation of bids, the Tribe may, within funding limitations, give preference in the amount of 5% above the lowest total bid, to qualified Indian owned firms.

Each contractor is required to be certified by the Tribal Employment Rights Office (TERO) **prior** To submitting a bid in accordance with the Northern Cheyenne TERO Ordinance. The contractor is required to comply with the requirements of the Northern Cheyenne Tribal Employment Rights Office. The contractor is responsible for payment of all TERO fees.
