NOTICE IS HEREBY GIVEN that the Northern Cheyenne Tribe of Lame Deer, Montana, will receive bids until **September 4, 2018** at the hour of **4:00 PM (MT)** at the Tribal Offices located at 600 Cheyenne Avenue, Lame Deer, Montana, 59043 or by mail to PO Box 128, Lame Deer, Montana, 59043. The bid documents shall be sealed and endorsed, "**Reservation Wide Asphalt Paving**". This is for the furnishing of materials, labor, equipment and skill required for the purpose of **mainline asphalt paving and incidentals** as is more fully described and set forth in the Project Manual and Plans, which is now on file in the office of the Northern Cheyenne Tribe, Lame Deer, Montana. Bids shall be publicly opened and read on **September 5, 2018** at the hour of **10:00 AM (MT)** at the Northern Cheyenne Tribal Council Chambers in Lame Deer, Montana.

The project generally consists of, but is not necessarily limited to, the following major items:

Mainline asphalt paving and incidentals at the following locations on the Reservations:

- **BIA Route 4 South 2 Miles**
- **Lame Deer Head Start Parking Lot**
- **BIA Route 5 Bridge Approaches**
- **Intersection of Two Moons Road and U.S. Highway 212**

The Contract Documents consisting of a Project Manual with plans and details may be examined or obtained, or a site visit scheduled from Renessa Russette at the Northern Cheyenne Tribe Procurement Office at 600 Cheyenne Avenue or by calling (406) 477-4810.

Bidders are responsible for contacting the Tribe with regard to Tribal tax laws and the business license fee and other requirements. The taxes include contractor's excise, sales and use taxes, additional information is included in the specifications. For more information, contact the Northern Cheyenne Tribe, PO Box 128, Lame Deer, MT 59043 and (406) 477-6287.

The contract work shall be completed within 90 days, in accordance with the Special Provision for Contract Time. Upon award of the contract a Notice to Proceed will be issued stating when construction operations are to begin.

The Northern Cheyenne Tribe reserves the right to reject any and all bids, to waive any informality in any bid, to hold all bids for period not exceed sixty (60) days from the date of opening bids, and to accept the bid deemed most favorable to the interest of the Tribe.

Should the Contractor fail to complete the work within the time required herein or within such extra time as may have been granted by formal extensions of time approved by the Owner, there will be deducted from any amount due to the Contractor the sum of \$1,000.00 per day for such working day that the work

is not complete. The Contractor and his surety will be liable for any excess. Such payment will be as liquidated damages and not as a penalty.
