Request for Proposal Attorney/ Legal Services Northern Cheyenne Tribal Board of Health August 26, 2019

The Northern Cheyenne Tribe (NCT) is soliciting bids for professional Attorney services to maintain and conduct legal review for all necessary documents pertaining to the Tribal Premium Sponsorship Program for the success and continuation of the program. This is a Fiscal Year service contract for the Board of Health program located within the Northern Cheyenne community in Southeastern Montana.

Background:

Consultant will provide professional legal services for Fiscal Year 2020, starting October 2019 and running through September 30, 2020. The legal services will be provided to the Tribe, whose headquarters are located in Lame Deer, Montana. The legal services will be performed both off and within the exterior borders on the Northern Cheyenne Reservation, which will include but is not limited to:

Scope of Work:

- The Attorney agrees to provide professional legal services to the Board of Heath concerning Tribal Health Programs, including but not limited to maintaining and the continuation of the Tribal Premium Sponsorship Program.
- The Attorney will provide services to revise the policies and procedures, legal review for all necessary documents, finalize program forms, enrollment applications, annual financial update forms, internal processes forms, and other forms/documents to be determined for the continuation of the Tribal Premium Sponsorship Program.
- The Attorney agrees to devote their professional resources to fulfilling the obligations of this agreement.
- Compensation. The Attorney will be compensated for all work and services performed under this agreement. The Tribe agrees to pay the Attorney for all work and services according to a following fee structure: Travel expenses approved in advance by the Tribe will be reimbursed. Mileage will be the current IRS rate (applies only to use of personal vehicles for travel). Postage will be reimbursed for actual cost. Copies will be \$.025 per page and faxes will be \$0.25 per page. The Consultant will invoice the Tribe on a monthly basis.

considered. All required documents must be in the bid prior to opening and received by the bid submission deadline.

REQUIRED DOCUMENTS INCLUDE THE FOLLOWING:

INDIAN PREFERENCE. The owner will factor Indian preference into the bid analysis process however it will in no case be the sole deciding factor in awarding work. Evidence of eligibility for Indian preference must be submitted with the proposal. Responsible bids will be accepted from Non-Indian owned contractors. In evaluation of the bids, the Tribe may, within funding limitations, give preference in the amount of 5% above the lowest total bid, to qualified Indian owned firms.

TERO. Each contractor is required to be certified by the Tribal Employment Rights Office (TERO) in accordance with the Northern Cheyenne TERO Ordinance. The contractor is required to comply with the requirements of the Northern Cheyenne Tribal Employment Rights Office.
