ITEM #1 - ELDERLY UPDATES

MICHELENE BEARCOMESOUT

-Our elders are taking care of grandchildren but they are also taking care of great grandchildren.

- -We are losing our young people but we are losing our elders faster. You should think about helping these young people.
- -Elderly program is currently serving around 140 elders at the Shoulderblade complex.
- -Home delivery to Busby and Hwy 212 is 6; Lame Deer is 20; Birney is 11. We will continue service as long as our budget allows.
- -Care giver training; we had 32 attendees. They were people that took care of elders.
- -We will schedule activities as soon as we can open regs and get them approved.
- -\$14,123.58 cents in activities but they've spent none of it because the accountant doesn't allow. Finance people won't talk to the program people. Requisitions get kicked back.
- -Email from Madison from the State office in Red Lodge in Area 2 on aging. They want to know where the \$25,983.00 is. That was ARPA's funds. They sent it buy a new stove, cooler and shipping bags and a food slicer. The paperwork was submitted with prices of how much everything was with an invoice. It was submitted but kicked back because the accountant said there was no budget and the money wasn't there. The Red Lodge Area Office 2 is asking for receipts by September 17th or they would like the money back. There was a budget submitted. I don't know if it was missing stuff but it sat on somebody's desk and was just returned recently. The accountant said, no, we are just going to send the money back.
- -Sysco wants money orders because a check bounced.
- -When changes were made to the financial manual, we were not given training on it. As Program directors, we are in the dark. We are not communicating as people.

KRISTI HARRIS:

-Walmart does not accept checks so we usually make the check out to an individual and they bring the receipts back.

TERRANCE LIMPY:

- -The stove; I was in contact with Roberta and Lorna. The budget was submitted in March of this year. It got lost in the shuffle.
- -The ARPA money was directed through the State not from the Treasury. They are Asking for the money back by 6/30. The requisition was in there but an invoice was never submitted; product was never delivered. It's past that point so they asked for the money back. I asked Roberta to reach out to the funding agency and I never heard anything back.

COUNCILWOMAN FISHER: Finance is going to work closely with you and Roberta to get it resolved.

ITEM #2 - DISTRICT UPDATES

RYHAL ROWLAND - MUDDY DISTRICT

- -Update on the hall. Tommy started on it again today. We had a district meeting last week and picked out the interior colors. It will be filled with insulation this week. Our security cameras need to be installed before they put the tin in.
- -Playground update: I was informed by the ARPA staff that they are using graveling. By

- October 8th, they should be working back on our district playground areas in Rosebud Subdivision and Muddy Cluster.
- -Land Board: Couple people that have been waiting for their homesites to be approved since April and they haven't received anything.
- -People are asking how to get their roads graveled. Who do they reach out to?
- -Debbie will follow up on the installation of the cameras and the basketball court.
