#### **ANNOUNCEMENTS**

President Peña-Mr. Eaglefeathers, why do we have personnel on the agenda?

Dana Eaglefeathers-At the last meeting there was some directives that you and the liaisons had 10 days and the 10 days had lapsed.

President Peña -I did pass out a packet here. I did not hear from the liaisons. I need to know where the money is going to come from.

Dana Eaglefeathers-The process should have been appointment and we could have gone through the process.

Ernest Littlemouth-We have a church group in Birney from Mississippi this week. They have stuff going on every day. They're going to show a movie and Thursday is adult day.

Diane Spottedelk-Do we have transportation for it for other districts to attend?

President Peña - Who is sponsoring?

Ernest Littlmeouth-It's call Hope Church from Mississippi. They start at 9:30 every day. The trip to Arapahoe was good, the diabetes program.

Dana Eaglefeathers-On August 21<sup>st</sup> we've been working with the state CPS office. We're trying to help our Cheyenne kids come home that are in the system. See if someone, if not all of us can attend. Per the President's request, I tried to set up a follow up meeting. That's been three weeks ago. The case that's going up to the adoption committee, it's that Fercho case. They're asking that the President/Vice President to attend.

Debra Charette-Where at?

Dana Eaglefeathers-Great Falls

#### DISTRICT UPDATE-SHELDON KING

Sheldon King-We did finish our hall. We had all the stuff that was put there that was purchased. I had four guys get in there and finish it in 2.5 days. I want to do a Boys & Girls Club. We want to allocate that as a spot. Our water is still down. There was some stuff we had taken care of. We had \$28,000 for a baseball field. We need bathrooms, and maybe we can reallocate that money for bathrooms and showers. We're all moving forward in Busby. We're getting ready for our backpacks. We had \$862 for backpacks from our Indian Relay. Let's do our part as a community and we'll come together and find a solution. We have a pretty good crew up there.

President Peña -I'm having a monthly meeting with all the chairs. We're trying to meet with the Chair of each district with myself and my office. We'll provide lunch.

Sheldon King-I've been in contact with the guy that owned Crow Merc, to try to get their air conditioner.

Henry Speelman-Everyone silence your phones.

President Peña -Friday the 16<sup>th</sup>, we have a Tribal Holiday. I'm in Billings on the 14<sup>th</sup> & 15<sup>th</sup> with Tribal Leaders.

# **ENROLLMENT-WALLACE BEARCHUM**

Dana Eaglefeathers-Where are we at with the new enrollment Ordinance? Did we do the process? Did we take it out to districts? Every time you come to the floor, there's 50, 80, 100 that are getting adopted to the tribe.

Wallace Bearchum-I gave it out in June.

Henry Speelman-We said we would have a working session, we'll put it on the next meeting.

Dana Eaglefeathers-Monday?

Henry Speelman-Yes.

Dana Eaglefeathers-If they relinquish, can they re-enroll again?

Debra Charette-Yes.

Kristina Quaempts-How do you guys justify an Ordinance superseding our constitution. I don't remember that going out to the membership relinquishing that half? How does the Council

Lavonda Brady-Do you guys provide a family tree? Do you ask family members if they approve it? I heard that a man in Busby got \$60,000 and another person got paid \$10,000. At some point, you're going to have to include family members. No one is protecting our blood quantum. Where is the documentation? The committee approved it, but my brother didn't sign the paternity. The child got enrolled. The lady isn't from here. There was no signature on the father's side, the child got enrolled. You have to develop something. The Council is supposed to protect the memberships rights. There's ways of proving it. You're not protecting the membership.

Debra Charette-The committee does provide a family tree. The applicant puts one on there. They print out their information they have on file.

Lavonda Brady-There was a lady that told me, Ernie Robinson has a card that says he's over half. We know the family, how can that happen? Someone didn't protect our blood quantum. What options do you have? That lied about it and Can you guys prosecute someone? We know what they look like, I went around looking at a lot of people, you look at the color of their skin. Those people that are a quarter, their still dark skinned. Most of the time, that's what I've seen. You look at Ernie Robinson, he has blue eyes, brown hair, and light skin. You have to protect it, you're the Council. There are some laws, there's nothing there that protects them. What are you going to do with those that violate that? Falsifying information. How did they get around doing that? You know a lot of people are messing around with it. You have to do something.

Kristina Quaempts-What's taking so long? To redo that Ordinance? I've seen old minutes. One of the officials, there was a family that adopted children that weren't even his into the tribe.

Dana Eaglefeathers-The new Ordinance has DNA and Blood Quantum and everything.

Kristina Quaempts-It still doesn't supersede the constitution.

Dana Eaglefeathers-This body has tabled this two times.

Kristina Quaempts-It should go out to the people.

President Peña -He presented here, there was only 7 of us here.

Dana Eaglefeathers-It was presented to the previous Council as well.

Lavonda Brady-If you read the constitution the Council to vote, you have to be more than half as well. Cobell said we have to give all that money back. Each person should have received \$25,000, we got \$2,500.

Kristina Quaempts-Was the unclaimed per cap given out?

Debra Charette-It's still sitting there.

Kristina Quaempts-So my sister can still get her per cap?

President Peña -I'm still signing per cap checks.

Kristina Quaempts-I'll bring her paperwork in.

Lane Spottedelk-Unclaimed percaps, you have to go through tribal enrollment. Maybe the enrollment chair can help you through that process.
