ANNOUNCEMENTS

Lane Spotted Elk: I have an announcement, Madame President, Vice President, Colleagues on the Council—On February 11th at 9:00 a.m., there will be a TBIC (Tribal Budget Interior Committee) Meeting. I was an alternate for TBIC for the last two fiscal years, and the former Chairman Not Afraid was our delegate. But, he did not get in, so I will be the delegate for Rocky Mountain Region for TBIC. I invite everyone to sit in on this call at 9:00 a.m. to participate in this TBIC meeting.

Norma Gourneau: Madame President, I have an announcement. On Wednesday, we will be touring the Federal Court Building in Billings, it is scheduled to start at 1:00 p.m. Thank you.

Donna Fisher: Where do we meet?

Norma Gourneau: At the Federal Building. It's being done through the U.S. Marshall's Office for this tour.

Diane Spotted Elk: I have not so much an announcement, but a clarification on the two resolutions that I will be presenting. One is the Language Enhancement. In that, I am attempting to initiate a plan of how we can preserve...due to the pandemic, you know we have lost a lot of fluent speakers and we are beyond crisis. I'd like to establish a task force for the districts. Whether it needs to be on the agenda too, or if we need further discussion on it. And secondly, the housing development. After speaking to Rae and what I'm trying to do in response to the pandemic and families, 3-4 families living in one household; how do we help in getting more housing? She had an idea and so we're going to have a discussion on how to get a lot of these boarded-up houses open and occupied. So, whether I need to table those two issues for now and have further discussion on them and put them on the next agenda, I guess is what I'm asking everybody.

Debra Charette: Well, what do you have from Dull Knife? Because Dull Knife is kind of the one that is taking the lead on preserving the language.

Diane Spotted Elk: Yeah, in terms of education. This is kind of grass roots, because of the situation we are in now, we need to take another approach. They will continue to do Indian education for all, and that's where their expertise is. But as far as districts and community trying to help, too, without the class setting and those astringents which are almost a hindrance sometimes.

Donna Fisher: I think it's going to take every entity, like Dull Knife has its own language program. We could start at a younger age, and bring it into a little emergent school for the younger children who absorb everything. So, I think that's something we should take a really good look at, is starting our own little emergent school through head start.

Diane Spotted Elk: So, I think we can table it for now and then have further discussion during the next agenda meeting, and then put it on the 15th. If that's okay with everyone. Thank you guys.

Lane Spotted Elk: I would like to propose an add on. On Friday, we received a resolution to be considered by the council to continue re-contracting the road maintenance program. So, I think Secretary Robinson has those copies to be considered as add on. It was not included when we do our annual re-contracting, it's kind of a program that requires its own resolution. So, I would like to make a motion to continue this as an add on, to continue to re-contract our road maintenance department. Thank you.

A RESOLUTION TO SUPPORT REPROGRAMMING FUNDS FOR CONSTRUCTION OF A NEW NORTHERN CHEYENNE FOOD BANK AND TO HIRE BEARSTAR ENTERPRISES AS THE CONTRACTOR.

Lane Spotted Elk: So, I just want to introduce, well, Emma is part of our Task Force. Councilwoman Little Eagle, Councilwoman Spotted Elk, Councilwoman Charette, and myself. A few of us have been talking about this and Emma has been at the forefront of our COVID Response. So, when a family tests positive or is identified as a close contact, she has been leading that charge and her dedicated staff. I wanted to recognize her, all of us have benefited from this. So, I want to thank you, Emma—you and your staff are doing such a great job, going above and beyond. Evenings, weekends, holidays, putting the service ahead of yourselves and understanding the greater mission. I just wanted to thank you, Emma.

(All Council stands and applauds to honor Emma and her staff.)

Emma Harris: I just wanted to say that a lot of people ask, what's in it for me? But for me, my dad, he always cared about people. He worked for housing for years and saved everything, saying someone might need this. He instilled in me that we take care of each other. I don't care about the money, I just care that we help each other in a good way. And so, my staff is the same way, and I am really blessed with them. It's a blessing to have the resources to help someone. And even the older people, they may not have COVID, but we help them anyway. Because that's how we care for each other. And I really appreciate you guys recognizing me. It means a lot to me. Material things don't mean anything to me, but what you've done just touches my heart. Thank you.

Lane Spotted Elk: I just have a quick amendment. I think in here we budgeted some money from CARES ACT, so I wanted to make sure that's included in here that the origination of the funds will be from the CARES ACT funding. And later this week, the accountant and CARES ACT team will work on getting that figure. So, what I propose later this week, is that we can all sit down and go over that and kind of accommodate those budget requests. I know we have some outstanding that we need to look into, like Solid Waste has a proposal in for covering their vehicles, things like that. So I wanted to see if Thursday at 10:00 a.m. works for everyone. We can review the CARES ACT, and once we get all of that situated, I request for a special on Thursday afternoon to make those modifications and get that budget approved so we can move forward. And then that way, we can help the CARES ACT obligated, and when the new funding comes in, hopefully in a few weeks, I know the Upper Chambers Senate will be meeting on this this week, so we can have our priorities listed for the new funding. So, if that sounds good with everybody, we can get that done Thursday. That is my modification to this. Is identifying that the funding would come from the current CARES ACT funding, and I can list the land description over here that has been approved by the land committee. And Abdullah, you've measured that out? Did you want to say a few things, Abdullah?

Abdullah Ramhormoz: We have plenty of room there. Especially so they can drive through and get their food there.

Lane Spotted Elk: I know some of us went down to look at the Wellness Center, and it has a second floor. But what I was thinking was, that we are trying to expand our Economic

Development Department and right now office space is an issue. But if we could add the second floor for office space for Economic Development or any other program that needs office space, that's valuable second floor space that the Tribe can really utilize. Abdullah's going to get that drawn up and the architects are going to work on that, so by Thursday we can get that figured.

Donna Fisher: Abdullah, I'd just like to see... as you're contracting, I'd like to see labors from the TERO Bank and any other contractors that are Tribal. I just ask that you utilize our tribal members.

Abdullah Ramhormoz: (Shakes his head yes in agreement)

ELDERLY UPDATE

Silver Little Eagle: We were able to butcher the two cows last Friday, and we should be distributing the meat probably next week. And that's about 1200 lbs?

Henry Speelman: One is about 435, and one was 410 lbs. So, 845 lbs.

Silver Little Eagle: So, it would be distributed as hamburger meat and short ribs.

Donna Fisher: Is that just for the elderly program or are you going into districts?

Silver Little Eagle: We'll probably distribute from the elderly program because they have the drive through.

Henry Speelman: I would like to have you send a thank you letter out to O.W. Ranch, thanking them for helping our elders.

DISTRICTS

Muddy District

Ryhal Rowland: For Muddy District, we do need a new furnace. We never received anything from the CARES ACT.

Donna Fisher: So housing has CARES ACT available, they said they are going to secure it, but you might want to go down there and see if they can put a furnace on there.

Melissa Fisher: When Rocky talked to me and Gwen, he said that they had scopes of work drawn up for all the Districts. So, you can probably go and see him and see what they have in your District's scope. And let him know there is a higher need for a furnace.

Ryhal Rowland: Okay.

Donna Fisher: So, did we get a start date from Little Coyote Construction?

Melissa Fisher: I think it was last week that you signed his contract. I haven't heard back from him yet, but I can message him.

Donna Fisher: Okay.

Lame Deer District

Lame Deer District Representatives, Max Guavera and Nellie Ann Whiteshield enter the session @ 9:42 a.m.

Nellie Ann Whiteshield: It's been a while since we've been having meetings due to all these COVID issues, but there are a lot of concerns for our people. We've been trying to keep our homeless shelter going, and we have some minor repairs that still need fixed. That's coming along. I am getting concerned, we have asked one person to move back into the shelter because it's getting cold, but he said the Tribe had given him a small shed. So, I don't want us to be responsible if anything should happen to that young man. Secondly, our budget. I put aside \$1500 to finish fixing the big hole we had in our ceiling that needs to be fixed. So, I took it upon myself to get it taken care of. We still don't have a stove or showers. We're working on it. As of the end of this month, we will start our regular meetings again, but like we said, we don't have a proper meeting place. We were able to utilize the chambers before by Hank Wolfname at that time. We're trying to get out as much assistance, the ones who need propane and water, and that's as much as I have right now. And medical—from our budget, we will have to add more to our medical because a lot of kids are getting hit with this COVID. My great grandson almost passed from it, but he pulled out of it. So, we will be moving some money back to a medical line item, because there's too many that are up there right now. Do you have any updates, Max?

Max Guavera: I've been getting told I can't pick any more food up because I've already gone through the line. But it bothers me because I'm taking boxes to Birney and others who need those food boxes. (Max Guavera raised concerns about having help for others with medical bills and expenses, and having to deliver checks to others. Henry Speelman encouraged Max Guavera to meet with him the following morning to discuss his concerns, and Max agreed.)

Henry Speelman: Thank you guys.

Max Guavera and Nellie Ann Whiteshield exit the session @ 10:01 a.m.

Busby District

Sheldon King entered the session @ 10:02 a.m.

Sheldon King: Good morning! Busby District update, I know we're still working on our budget. The girls that I work with up there, they went through COVID and now they're dealing with their dad, so it's kind of put a hassle on our budget a little bit to turn it in and get it approved. I know that we have money in there, we have carry over of \$16,000. We've applied for grants through Fonda Red Fox, we've done that \$40,000 for a Montana Tourism grant. Last week, was the beginning of the work on our arbor, our lights. CEI out of Colstrip came in and started doing that. Updating to LED lighting. So, we're moving forward up there, but because of COVID, it's at a bit of a snail pace. This morning, with you all approving the kitchen equipment for each district, that's what I was unloading. We have a shipping container over there and it's getting full of all the kitchen equipment. All districts all got the same thing—freezers, refrigerators, fryers, mixers, pots and pans...it's a lot of stuff that everyone was included on. They're all stainless steel commercial grade. Are there any questions?

Phillip Beckman: Awesome. No questions, we just want to commend you for all the work you've been doing up there.

Sheldon King: One more thing—I have a lot of contacts out there and a lady named Stiffler, comes out of Florida. And she's working with all the South Dakota tribes, and Colorado, on getting food banks and homeless shelters. Those are her two main things, and so she's looking at state and federal regulations and what we can get for funding.

Lane Spotted Elk: Can we have a conference call with her?

Sheldon King: Yeah.

Lane Spotted Elk: Yeah, set one up and let us know.

Sheldon King: Yeah. She checks out the state and everything and she's going to break it down and she's very knowledgeable.

Donna Fisher: I think we need to start with a steering committee. And that's what will guide us through, all of our homeless shelters and our food banks, and all of our regulations that we have to put in place before we can even start to bring food in, and distribute it, and...there's just so much regulation to it. And to pull grants in from USDA, you have to have all the stuff in order. Yep, that will be good.

Sheldon King: I would also really like some running water in our district hall. We have heating, but it's not to where we want to be at in case of an emergency, where would we take our elders, you know.

Donna Fisher: So, Sheldon, will you need your own well or would you hook into city water?

Sheldon King: Yeah, there's still a conflict there with the hook up. And the projects have not been completed. I want to be able to actually use our community building again. Another thing that the community wants to know, is that is there going to be an election for Busby school?

Donna Fisher: Is that something the council is in charge of?

Debra Charette: We had put it off until December and that's what I was asking Wallace, was a copy of that resolution, so we can follow what we put out there. And I had made that request on Thursday. I'll have to check with him.

Norma Gourneau: I have a question, who facilitates that election, the school or the tribe?

Sheldon King: The school does.

Lane Spotted Elk: We can research that and get back to you.

Sheldon King: Okay, great.

there's a lot of regulations that we need to go through, we decided...I had attended a session where it was recommended that we appoint a committee to keep this project going because it serves such a greater good for our communities. So, this resolution was drafted and what it essentially is going to do is...let's read it. (Norma Gourneau reads the Resolution). We have given a list of suggested names for the President to bring forward and that is the resolution that is being presented today for consideration. So, if the Tribal President could list out those recommendations, we would appreciate it.

Donna Fisher: Norma, is there already a board structure set up?

Norma Gourneau: No, that would be their task.

Donna Fisher: Okay, so the committee will consist of two tribal members and three tribal council. Kyle Alderman is recommended, Richard Sanders is recommended, Debra Charette, Lane Spotted Elk, and Melissa Fisher are to sit on the board in the council's capacity.
